Special Recognition Class for Retired Agility Dogs**

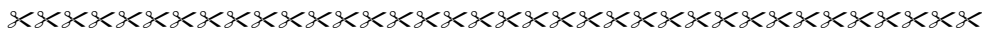
**Description:**
